Dear Mr. Chaney:

This is a Notice of Violation regarding the Southeast Correctional Institute wastewater treatment plant (WWTP). The Ohio EPA wastewater discharge permit (Ohio EPA No.: 4PP00011\*DD) schedule of compliance requires submittal of a Permit to Install (PTI) by September 1, 2010 for WWTP improvements. There is no indication in our records that a PTI has been submitted.

Please inform me, in writing by November 22, 2010 as to the reason(s) for the above referenced violation, as well as a description of action taken or proposed to prevent any further violation. Your response should include dates, either actual or proposed, for completion of the action.

Please be advised that failure to comply with effluent limitations or to satisfy monitoring or reporting requirements of your wastewater discharge permit may be cause for enforcement action pursuant to the Ohio Revised Code Chapter 6111. Continued wastewater discharge permit noncompliance is unacceptable.
