Re: Notice of Violation – Terry L. Henson, Jr., dba Henson Flooring National Pollutant Discharge Elimination System (NPDES) Ohio EPA Permit 4PR00005*ED

Dear Mr. Henson,

This correspondence serves as a **Notice of Violation (NOV)** for noncompliance with requirements of your NPDES permit for the Henson Flooring wastewater treatment plant (WWTP).

Enforcement action which may include a penalty may be initiated unless you submit documentation by June 27, 2011, demonstrating that you have made arrangements for submittal of monthly discharge monitoring report data required by your wastewater discharge permit. Monthly discharge monitoring reports must be submitted even if there is no discharge from your WWTP.

Violations

1. Violations of the NPDES discharge permit have, and continue, to occur. Discharge monitoring reports have not been submitted to this office as required.
2. Violation of the terms and conditions of NPDES Permit 4PR0005 is also a violation of Ohio Revised Code 6111.07 which states:

6111.07 Prohibited acts - prosecutions and injunction by attorney general. No person shall violate or fail to perform any duty imposed by sections 6111.01 to 6111.08 of the by the director of environmental protection pursuant to those sections. Each day of violation is a separate offense.
