Dear Ms. Burnham & Ms. Carabell:

On April 23, 2008, this office conducted a compliance evaluation inspection (CEI) of the wastewater treatment system serving the above referenced facility. Present during the inspection were this writer and Wade Bowers, Thunderbird Terrace MHP. The sewage treatment system is currently serving 49 mobile homes.

The existing sewage treatment system consists of a 1,000 gallon trash trap followed by an 8,000 gallon per day extended aeration treatment plant consisting of an aeration tank and a settling tank. The system discharges to an unnamed tributary to Sherrick Run.

At the time of the inspection, the contents of the aeration tank had a grey color. The treatment system was discharging partially treated sewage. The receiving stream is still being severely degraded from this discharge. The stream bed was covered with sewage fungus.

An effluent flow meter has been added to the treatment system. The daily flows to the treatment system are exceeding the capacity of the existing treatment plant.

A review of your monthly operating reports covering the period October 2007 through March 2008 revealed no effluent violations.

Your NPDES permit became effective on September 1, 2007. The schedule of compliance, Part I, C, requires detail plans for treatment system upgrades to be submitted to this office by March 1, 2008. To date, this office has not received these plans. Therefore, you are in noncompliance with your NPDES permit.


The NPDES permit also requires the operation of the treatment plant to be supervised by a Class I State Certified operator.
