Dear Mr. Dakin:

The National Pollutant Discharge Elimination System (NPDES) permit for the wastewater treatment works (WWTW) serving Wayne Mobile, Inc., requires upgrades to the WWTW in order to meet the final table effluent limitations. According to Part I, C. "Schedule of Compliance" within the NPDES permit, Wayne Mobile Inc. was required to *submit detailed plans for plant and sewer system improvements by no later than 8 months from the effective date of the permit* (which would be February 1, 2011). To date, this office has not received this information. This is a violation of the terms and conditions of the NPDES permit and this office will begin prepare an enforcement action against Wayne Mobile Inc.

In order to avoid an enforcement referral, Wayne Mobile Inc. must contract with a professional engineer, licensed in the State of Ohio, to prepare approvable detailed plans for submission to Ohio EPA Southwest District Office. The engineer must also contact Ohio EPA no later than February 21, 2011, to discuss a new submittal date and efforts that will be made to begin construction on the WWTW by the compliance schedule date of no later than 16 months from the effective date of the NPDES permit (which would be September 1, 2011).
