Dear Mr. Jones:

On September 16, 2009, an inspection was conducted at the above referenced facility by the undersigned. The facility was represented by Mr. Kent Kelley, Park Manager. The purpose of the inspection was to evaluate the facility's compliance status with respect to the terms and conditions of the above-referenced National Pollutant Discharge Elimination System (NPDES) permit.

The current 15,000 gallon/day treatment system consists of a flow equalization basin, extended aeration activated sludge "package" plant, final settling tank, slow surface sand filtration, sludge holding, and chlorination/dechlorination.

At the time of the inspection, the operation and maintenance of the treatment system appeared to be adequate. Mr. Kelley was advised of the need to keep weed growth on the sand filters under control. The final effluent was clear with no visual evidence of adverse impact in the downstream segment of the receiving stream.

A review of the facility's Discharge Monitoring Reports (EPA Form 4500) received by Ohio EPA for the period, January 2008 - September 2009, indicate violations of the terms and conditions of the NPDES permit. The specific instances of noncompliance are as follows:
