Dear Mr. Coon:

You are hereby cited for violations of the Ohio Administrative Code section 3745-17-08 (B)(1) (Fugitive Dust) and Title 9 Section 97.01 of the Akron Code of Ordinances. These violations have occurred on your jobsites at 55 E. Mill Street and 168 E. Market Street in the City of Akron (Summit County).

On April 21, 2010, our office received a complaint alleging grinders being operated and creating a lot of dust at the corner of Mill and High Streets in the city of Akron. During an investigation, on April 21, 2010, an inspector from the Akron Regional Air Quality Management District (ARAQMD) observed dust on the site; the result of grinding mortar from joints on a retaining wall. Contact was made with Lee, an employee of Coon Restoration & Sealants, who admitted grinding without the benefit of dust control. The employee further stated he was aware of the fugitive dust regulation. The inspector gave verbal orders to the employee to cease and desist all illegal grinding/sawing activities and to utilize a dust control method during all grinding/sawing activities.

Previously, on August 17, 2007, an ARAQMD inspector observed an employee of Coon Restoration & Sealants using a die grinder to remove mortar from joints and saw cutting brick steps at 168 E. Market Street in the city of Akron without any form of dust control. At this time, contact was made with Jeff, the foreman, and written orders were issued to "cease and desist" all illegal sawing/cutting activities.



In light of this most recent violation, you are urged to take appropriate steps to be sure that no further illegal generation of fugitive dust occurs on this jobsite or any others. **Within fifteen (15) days of receipt of this letter, please submit a written plan and commitment to cease all further illegal generation of fugitive dust.**

Acceptance by this Agency of your commitment does not constitute a waiver of this Agency's authority to seek civil penalties as provided in Title 9 Section 97.29 of the Akron Code of Ordinances, or to refer the matter to the Ohio EPA for their enforcement action (including imposition of civil penalties). The determination to pursue or to decline to pursue such penalties will be made at a later date.
