RE: Notice of violation concerning the Auglaize County Solid Waste Management District's draft amended solid waste management plan

Dear Commissioner Bergman:

The purpose of this letter is to inform you that the Auglaize County Solid Waste Management District (District) is in violation of section 3734.56(A) of the Ohio Revised Code for failure to submit a draft amended solid waste management plan to Ohio EPA within five years of the anniversary date that the District's current solid waste management plan was approved. Specifically, section 3734.56(A) of the Ohio Revised Code states, in pertinent part:

Each county and joint solid waste management district having a solid waste management plan...with...a planning period of fifteen or more years...shall submit such an amended plan and certification to the director every five years on or before the anniversary date of the approval of the initial plan of the district.

The District's current solid waste management plan was approved on May 16, 2003 and contains a planning period of at least 15 years. Therefore, the draft amended solid waste management plan was due to Ohio EPA on May 16, 2008. Ohio EPA has not yet received the District's draft amended solid waste management plan.

Within 14 days of the date of this letter, please inform Ohio EPA, through a written response, of how the District will rectify this violation. In this response, please include a date by which the District anticipates submitting the draft amended solid waste management plan.


