Dear Ms. Karns:

The purpose of this letter is to inform you that the Clark County Solid Waste Management District (District) is in violation of section 3745-27-90(F) of the Ohio Administrative Code for failure to submit an annual report by June 1, 2007. Specifically, section 3745-27-90(F) of the Administrative Code states:

Solid waste management districts shall submit an annual district report on a form prescribed by the director not later than the first day of June each year.

In March of this year, Ohio EPA sent a copy of the *Calendar Year 2006 Annual District Report* form (2006 ADR) to the District directing the District to submit the completed form to Ohio EPA by June 1, 2007. As of the date of this correspondence, Ohio EPA had not received the District's completed 2006 ADR.


In an e-mail that you sent to Andrew Booker on June 4, 2007, you indicated that the District would submit the completed 2006 ADR by July 1, 2006. Ohio EPA will expect to receive the District's 2006 ADR by that date. If the District determines that it will be unable to submit its 2006 ADR by July 1, 2006, then please contact Channon Cohen with a revised schedule.


