Dear Mr. Taylor:

The purpose of this letter is to inform you that the Richland County Regional Solid Waste Management Authority (Authority) is in violation of section 3745-27-90(F) of the Ohio Administrative Code for failure to submit an annual report by June 1, 2007. Specifically, section 3745-27-90(F) of the Administrative Code states:

Solid waste management districts shall submit an annual district report on a form prescribed by the director not later than the first day of June each year.

In March of this year, Ohio EPA sent a copy of the *Calendar Year 2006 Annual District Report* form (2006 ADR) to the Authority directing the Authority to submit the completed form to Ohio EPA by June 1, 2007. As of the date of this correspondence, Ohio EPA had not received the Authority's completed 2006 ADR.

In an e-mail that Mary Wiard sent to Nick D'Amato on June 4, 2007, Ms. Wiard indicated that the Authority would submit the completed 2006 ADR by the middle of the week of June 11, 2007. As of the date of this correspondence, Ohio EPA had not received the Authority's 2006 ADR.


Within 14 days of the date of this letter, please contact Nick D'Amato and provide a date by which the Authority will submit its completed 2006 ADR. Please be advised that failure to rectify this violation in a timely manner may subject the District to escalated enforcement action.
