Dear Mr. Pask:

You are hereby cited for violations of the Ohio Administrative Code section 3745-17-08 (B)(1) (Fugitive Dust) and Title 9, Section 97.01 of the Akron Code of Ordinances. These violations have occurred on your jobsites in the city of Akron, Ohio (Summit County).

On September 21, 2010 our office received a complaint alleging the dry sawing of stone, thereby creating dust which was blowing onto motorists on the adjacent street. You were contacted at the jobsite on September 22, 2010. You acknowledged the dry sawing of stone on the previous day and were provided with a copy of OAC3745-17-08 (B) and written orders. This violation occurred on the Schumacher Mills jobsite located at the corner of Howard and North Streets in the city of Akron.

On August 13, 2008 an inspector from the Akron Regional Air Quality Management District (ARAQMD) observed an employee of Vizmeg Landscaping, Inc. using a leaf blower to "clean up" dirt and debris, generated by landscaping of the tree lawn, from the street. You, Dave Pask, were approached by the inspector who explained the Ohio Administrative Code section 3745-17-08 (B)(1) Fugitive Dust and provided you with a copy. You were also given written orders. This violation occurred at 565 N. Howard Street.

In light of these violations and non-compliance with the Ohio Administrative Code section 3745-17-08 (B)(1) (Fugitive Dust) and Title 9, Section 97.01 of the Akron Code of Ordinances, you are urged to take appropriate steps to be sure that no further illegal generation of fugitive dust occurs on any jobsites wherein you are employed. **Within fifteen (15) days of receipt of this letter, please submit a written commitment to cease all further illegal generation of fugitive dust and a detailed description of the dust control measures you will be utilizing.**
