Dear Mr. Keegan:

This office received a complaint on October 18, 2012, concerning open burning being conducted on property which your company operates on at 7250 East State Route 101 in Clyde, Ohio. My investigation, conducted on October 19, 2012, shows waste wood products were burned for disposal purposes and in the recent past multiple metal frame desks with plastic seats and wood desktops were burned to remove the unwanted wood and plastic components.

Based on these findings, there is sufficient evidence to determine that illegal open burning did occur and the complaint is justified. This is a violation of both Ohio Administrative Code (OAC) rule 3745-19-04(A) and Ohio Revised Code (ORC) 3704.05. A similar letter and the OAC rules are also being sent to Deanna Keegan because she, as the property owner, may be ultimately be held liable for current and future violations.

A copy of the OAC rules pertaining to open burning has been enclosed for your review. Please provide a written response acknowledging your receipt of this letter and your understanding of the rules. If you do not understand the rules please contact this office for additional explanation before responding. Your response is requested no later than November 12, 2012.

Because the fire has been extinguished, you are no longer in violation and the property is considered to have returned to compliance.


Please be advised that the submission of information to respond to this letter does not constitute waiver of the Ohio EPA's authority to seek civil penalties pursuant to Ohio Revised Code Section 3704.06. The Ohio EPA will make a decision whether to pursue such penalties regarding this matter at a later date.
