**RE: Darke County, Markwith Tool Inc., NPDES Permit Violations**

Dear Mr. Miller:

We have attempted to review your Discharge Monitoring Reports (DMRs) covering the months of October 2010 through September 2012 for the referenced facility. Our review indicates violations of the conditions of your NPDES permit (NPDES Permit # OH0118397; OEPA Permit # 11N00240\*CD). The DMRs for the noted period have not been submitted as required by the NPDES permit. These reports must be submitted immediately.

In addition, the current NPDES permit for your facility expires on March 31, 2013. You were required to submit the NPDES permit renewal application as soon as possible but not later than September 30, 2012. At this time, you have also failed to submit this renewal application.

A Notice of Violation letter was sent to you on June 5, 2012 addressing many of these violations. A response was required to be submitted by June 22, 2012. At this time, we have failed to receive a response to this Notice of Violation letter.

As a result of these violations, this office has recommended that enforcement action against your facility be pursued in accordance with Ohio Revised Code Chapter 6111. We would recommend that you submit the NPDES permit renewal application and DMRs as soon as possible.
