Dear Mr. Cartner:

On November 20, 2012, I performed a compliance inspection of your Motrim Inc. facility to determine its compliance with Ohio's hazardous waste laws and regulations as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

Based on this inspection, the following violation was discovered; however, the used oil drums were properly labeled during the inspection:

- (i) Used oil storage requirements for generators, OAC rule 3745-279-22(C). Containers and above-ground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

All violations cited during the inspection have now been abated. I have attached the checklists I used to evaluate your operations. I have also included factsheets regarding spent bulb management.
