Dear Mr. Green:

Thank Lew Modic, Production Manager, and you for accompanying me during the January 27, 2010, hazardous waste compliance evaluation inspection (CEI) of AMETEK-Westchester Plastics (AMETEK) located at address stated above. This inspection was conducted to determine AMETEK's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC), and Ohio's hazardous waste regulations as adopted under Chapter 3745. of the Ohio Administrative Code (OAC). The inspection included a tour of facility operations and a review of facility paperwork. This letter will list the violations I found. All found violations were abated during this inspection; therefore, no further action is required at this time.

AMETEK is an independent toll compounder of engineering resins, alloys, blends, reactive modifiers and other thermoplastic materials. At the time of inspection, AMETEK was operating as a conditionally exempt small quantity generator of hazardous waste. Hazardous waste generated onsite include: spent methanol (D001) generated at an on-site lab where quality control physical testing is routinely performed. Less than one gallon of spent methanol is generated per week. Other non-hazardous waste streams generated at the facility include: spent light bulbs (being managed as universal waste), used oil (being recycled off-site), residual plastic (recycled on-site), cardboard (recycled off-site), wooden pellets (recycled off-site), and super-sacks (recycled/reused).

I found the following violations of Ohio's hazardous waste laws. As previously stated, all violations were abated during the inspection.

1. OAC 3745-279-22(C)(1) Used Oil Management – Container Labeling

Containers used to store used oil shall be labeled or marked clearly with the words "Used Oil".

METEK failed to mark all their containers used for used oil storage with the words "Used Oil".

The containers were labeled during the inspection. **Therefore, this violation has been abated.**

2. OAC 3745-273-14(D)(1) Universal Waste Container Management

A small quantity handler of universal waste must contain any lamps in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the content of the lamps. Such containers or packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

AMETEK failed to maintain a container of waste lamps closed.

The container of spent fluorescent lamps was closed during the inspection. **Therefore, this violation has been abated.**

3. OAC 3745-273-14(E) Universal Waste Lamps Management -- Labeling

All lamps or containers or packages that are used to store universal waste lamps must be labeled with the words "Universal Waste - Lamps" or "Waste Lamps" or "Used Lamps". The length of time the universal waste lamps are stored must also be documented by marking or labeling the container with the earliest date when the universal waste became a waste or was received.

AMETEK failed to have the container storing the fluorescent lamps labeled with the earliest date of accumulation and the words "Universal Waste - Lamps" or "Waste Lamps" or "Used Lamps".

The container of spent fluorescent lamps was properly labeled during the inspection. **Therefore, this violation has been abated.**

As we discussed during the inspection, you may be able to reduce the waste your company generates. If you find ways to recycle, reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce treatment and disposal costs, and possibly reduce your regulatory requirements.


