NOTICE OF VIOLATION

Dear Mr. Channell:

It has been determined that, based on a complaint received from the Urbana Fire Division and our investigation, the open burning that occurred on or about December 6, 2012 at your 338 West Dallas Road, Urbana property constituted a violation of Ohio Administrative Code (OAC) open burning regulations.

The purpose of this letter is to:

- inform you of violations of Ohio's open burning rules; and
- request your cooperation to immediately halt any open burning that is in violation of the OAC open burning rules.

Open burning violations:

The open burning of household furniture and other waste materials constitutes a violation of OAC rules 3745-19-04(A) and 3745-19-04(B)(3)(c). OAC rule 3745-19-04(A) states that unless specifically listed under OAC rules 3745-19-03(B) to (D) or in section 3704.11 of the Ohio Revised Code, no person or property owner shall cause or allow open burning. Section 04(B)(3)(c) states that no materials burned may contain rubber, grease, asphalt or liquid petroleum products.

Immediate halt open burning in violation of OAC open burning rules:

Based on the above information, you are requested to halt any additional open burning which would be in violation of the Ohio Administrative Code.

The violations noted during the December 6, 2012 complaint investigation were rectified in a very timely manner. A subsequent inspection on December 10, 2012, verified a return to compliance. As such, no further action will be taken unless additional violations occur.
