To date, the Ohio EPA has not received the 2009 Consumer Confidence Report or Certification Form that was due by July 1, 2010. The Hayden Heights MHP public water system is in violation of Ohio Administrative Code (OAC) Rules 3745-96-01 through 04 for failure to comply with the Consumer Confidence Report requirements, the following violation was noted:

A Consumer Confidence Report or Certification Form for 2009 was not prepared or delivered. To return to compliance you must do the following:

1. Prepare a Consumer Confidence Report for 2009 and deliver a copy directly to each consumer within 10 days of the date of this letter.
2. Submit a copy of the Consumer Confidence Report to the Ohio EPA Central District Office within 10 days of the date of this letter.
3. Submit a completed Consumer Confidence Report Certification Form to the Ohio EPA Central District Office within 10 days of the date of this letter.
