Dear Mr. Ross:

On January 7, 2013, Rich Stewart and I inspected Hunter's Chrysler in Waverly, Ohio to determine Hunter's Chrysler's compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). During the inspection I also helped you identify ways to prevent pollution by reducing waste. This letter will explain the violation I found and what you need to do to correct the violation.

I found the following violation of Ohio's hazardous waste laws. In order to correct this violation you must do the following and send me the required information ***within 21 days*** of your receipt of this letter:

1. **Used oil storage requirements for generators, OAC rule 3745-279-22(C)(1):** Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."


During the inspection, the used oil tank was not labeled as required above. To demonstrate compliance with this rule, the tank must be labeled appropriately and photographic documentation must be sent to this office for review.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, Hunter's Chrysler is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
