**RE: Notice of Violation for Ohio Administrative Code (OAC) Rule 3745-27-14
Weidle Landfill, Montgomery County, Ohio**

Dear Mr. Weidle:

The purpose of this correspondence is to provide clarification regarding the regulatory obligations to submit an annual operating report for the closed Weidle Landfill.

OAC Rule 3745-27-14(A)(6) states in pertinent part:

"Post-closure care activities for a sanitary landfill facility shall include...Submitting a report to the appropriate Ohio EPA district office and approved health department and placing a copy into the operating record not later than the first day of April of each year, which contains the following: (a) If a leachate collection system exists, a summary of the quantity of leachate collected for treatment and disposal on a monthly basis during the year, and the location of leachate treatment and/or disposal, ... and (c) The most recent updated post-closure cost estimate adjusted for inflation and for any change in the post-closure cost estimate required by rule 3745-27-16 of the Administrative Code."

On or before April 1, 2013, and annually thereafter, Weidle Landfill will need to complete and submit an annual operating report for the previous year to Ohio EPA, Division of Materials and Waste Management, Southwest District Office and Public Health - Dayton and Montgomery County.


Compliance with the requirements outlined in this letter shall not relieve you of your obligation to comply with other legal obligations, including, but not limited to, Chapters 3704, 3714, 3734, or 6111 of the Ohio Revised Code or under the Federal Clean Water Act, Clean Air Act, Comprehensive Environmental Response, Compensation, and
