Dear Mayor and Council:

On June 1, 2004, the Director of Ohio EPA issued NPDES Permit Number 0PB00067*GD to you authorizing the discharge from the treatment works. The permit, which expires on May 31, 2009, requires you to submit a renewal application by November 30, 2008 in order to receive authorization to discharge beyond the expiration date.

As of the date of this letter, we have not received your renewal application. Since the application was not submitted as required, your discharge will be unauthorized if Ohio EPA does not issue the renewal permit by May 31, 2009. Unauthorized discharges are in violation of Ohio Revised Code Section 6111.04 and subject you to significant monetary penalties.

You should submit the attached forms along with \$200 application fee to this office as soon as possible. If we have not received a complete application before the expiration date, formal enforcement action will be initiated.
