Dear Ms. Lott:

Thank you for accompanying me during the September 15, 2009, hazardous waste compliance evaluation inspection (CEI) of Eaton Corporation (Eaton) located at 1660 Indian Wood Circle, Maumee, Ohio. This inspection was conducted to determine Eaton's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC), and Ohio's hazardous waste regulations as adopted under Chapter 3745. of the Ohio Administrative Code (OAC). The inspection included a tour of facility operations and a review of facility paperwork.

Eaton is a research facility for the testing of hydraulics. At the time of inspection, Ohio EPA considered Eaton a conditionally exempt small quantity generator (CESQG) of hazardous waste due to the fact that they did not produce over 220 pounds (approximately 25-30 gallons) of hazardous waste in a calendar month. The only hazardous waste generated is spent mineral spirits (D001) from the parts washers and spent lab wastes (D001, D035). Eaton also generates used oil and universal waste. Eaton's used oil and hazardous wastes are picked up by Safety Kleen. Their universal wastes are picked up by Environmental Recycling.

I found the following violations of Ohio's hazardous waste laws. In order to correct these violations you must do the following and send me the required information within 30 days of your receipt of this letter:

1. Universal Waste Storage, OAC 3745-273-13(D)(1)

A small quantity handler of universal waste must manage lamps in a way that prevents releases of any universal waste or component of a universal waste to the environment.

Therefore, a small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

Eaton's universal waste storage area for lamps contained multiple lamps which were not stored in closed packages.

In order to correct this violation, Eaton must place all their lamps in closed packages immediately. Eaton shall submit a photograph documenting that all lamps have been placed in closed packages.

2. Universal Waste Storage, OAC 3745-273-14(E)

A small quantity handler of universal waste must label or mark the packages of lamps with the words "Universal Waste - Lamp(s)" or "Waste Lamp(s)" or "Used Lamp(s)".

Eaton failed to have the boxes of used fluorescent bulbs labeled.

In order to correct this violation, Eaton must label the boxes of used fluorescent bulbs as stated above. Eaton shall submit a photograph documenting that the boxes have been labeled appropriately.

If you find ways to recycle, reduce, or altogether eliminate the amount of waste your company generates you may be able to reduce treatment and disposal costs. Furthermore, you may possibly reduce your regulatory requirements.

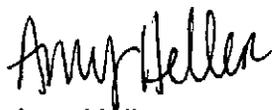
