NOTICE OF VIOLATION FOLLOW-UP LETTER

Dear Mr. Donelon:

On September 18, 2012, the Cleveland Division of Air Quality (CDAQ) issued a Notice of Violation requiring Great Lakes Contracting to submit a revised Notification of Demolition and Renovation (Notification). The Notification was received by fax on August 17, 2012. Additionally, on January 11, 2013, CDAQ received, via email, a statement explaining how Great Lakes Contracting saves all faxed revision notifications and documents all pertinent information for revised notifications.

The corrective action plan was received and appropriate steps were taken to bring the project into compliance. CDAQ has determined that no further enforcement action is warranted at this time, but reserves its right to take such action in the future if necessary.

CDAQ issues this letter with Ohio EPA's concurrence and does not excuse any violations of local, state and federal laws or regulations regarding air pollution control. Violations of air pollution control laws may be pursued in local court or referred to Ohio EPA or U.S. EPA for further enforcement action.
