Dear Mr. Kay:

Thank you for accompanying me during Ohio EPA's July 13, 2010, compliance evaluation inspection (CEI) of Kay Toledo Tag, Inc. (Kay) located at 6050 Benore Road in Toledo, Ohio. I inspected Kay to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). My inspection included observations of facility operations and a review of written documentation. This letter will explain the violation I found and what you need to do to correct the violation.

Kay performs custom printing of paper and synthetic tags. Kay's customers are diverse and numerous, including industry, transportation and government. The general process steps at Kay include slitting, printing, cutting/punching, reinforcing and finishing with string, elastic or wire. Printing methods include sheet fed off-set with plates, digital (for proofs or short runs), web letter press (using rolled paper) and flexo printing press (using rolled paper). Both water-based and soy oil-based inks are used. Both types of inks are non-hazardous and are reused, not discarded. Water-based inks are cleaned with water. Soy oil-based inks are cleaned with press wash solvent (D001). Kay's waste paper is recycled by Great Lakes Recycling.

Kay is currently operating as a hazardous waste conditionally exempt small quantity generator. Kay generates the following wastes:

1. Press Wash Solvent (D001): Soy oil-based inks are cleaned with this solvent blend. One type used is a mixture of heptanes and aliphatic naphtha with a flash point of 15°F. The solvent is applied with a small squeeze bottle and is wiped off with a rag. An extremely small amount of solvent is collected in a small tray under the rollers. No more than 10-15 gallons of this waste and the lacquer thinner waste (described below) is generated in a month. The solvent waste is shipped to Petro-Chem of Detroit, Michigan. The soiled rags are laundered by Domestic Linen Service of Detroit, Michigan.

2. Lacquer Thinner #3 (F003 & F005): If the soy oil ink hardens on a press component it can only be removed with this solvent blend. It is a mixture of toluene, acetone, methanol and MEK. A very small amount of this solvent blend is used. The waste is combined in the same drum as the press wash solvent.
3. Waste Lamps: Kay has been placing its spent fluorescent lamps in the trash.
4. Used Oil: Kay accumulates machine oil and lube in a 55-gallon drum. It is recycled through Cousins Waste Control/Philips of Toledo, Ohio.

As a result of my inspection, I found the following violation of Ohio's hazardous waste laws. In order to correct this violation, you must do the following and send me the required information, **within 30 days** of your receipt of this letter:

1. **Waste Evaluation**  
**OAC Rule 3745-52-11**

A generator must determine whether its waste is hazardous by testing the waste according to the methods set forth in rules 3745-51-20 to 3745-51-24.

Kay has failed to evaluate its spent lamps (all types), according to this rule and has been placing them in the trash. In order to abate this violation, Kay must evaluate its spent lamps. Instead of obtaining a sample of the lamps and having the sample analyzed in a laboratory, Kay may elect to manage its spent lamps (all types) as Universal Waste. During the inspection, we discussed these two options and you indicated you would like to manage your spent lamps as Universal Waste. The requirements for Universal Waste lamps include:

- Immediately cease placing spent lamps into the trash;
- Place spent lamps into containers that are structurally sound and closed;
- Label the containers with the words "Used Lamps";
- Document the length of time that the spent lamps are stored;
- Store spent lamps for no longer than one year;
- Inform all employees with the responsibility to collect spent lamps of these requirements; and
- Ship the spent lamps to a lamp recycler (please refer to the list of recyclers enclosed with this letter).

In order to abate this violation, please explain how you intend to manage your spent lamps and to comply with the requirements listed above. Indicate how you will package the lamps, label the containers, date the containers and inform your employees of the requirements. Please submit photos demonstrating that this has been done. Also, please indicate where you will ship the Universal Waste lamps to.

Please be aware that incandescent, fluorescent, metal halide, neon, high-intensity discharge, high-pressure sodium and mercury-vapor lamps could be hazardous waste when discarded. Fluorescent lamps may contain up to 40 milligrams (mg) of mercury, depending on the brand and manufacturer. Lamps may also contain lead and cadmium. Many lamps exhibit a characteristic of toxicity for heavy metals when disposed. I have enclosed copies of the following documents to assist you in properly managing your spent lamps: Fluorescent Lamps: What You Should Know and Computer, Fluorescent Lamp and Ballast Recyclers. I recommend that you review these documents carefully and contact me if you have any questions. The first document describes the rules you must follow in order to manage lamps as a universal waste.

As a used oil generator you are required to: store used oil in containers or aboveground tanks that are in good condition (no severe rusting, apparent structural defects or deterioration) and not leaking. Containers, aboveground tanks and fill pipes for underground tanks must be labeled with the words "Used Oil." If leaks are detected, the generator must: stop the release; contain the release; clean up and manage properly the released used oil and other materials related to the release; and, if necessary, repair or replace any leaking containers or tanks prior to returning them to service. I have enclosed copies of the following used oil fact sheets: The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil, and Used Oil Recyclers. Please review these carefully and contact me immediately if you have any questions.

You may be able to further reduce the waste your company generates. If you find ways to recycle, reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce your treatment and disposal costs and you may possibly reduce your regulatory requirements. I have enclosed copies of Pollution Prevention Opportunities, a worksheet that can help you recognize opportunities for reducing waste and conserving energy at your business, and the fact sheet Management of Electronic Waste from Businesses. Please review this information and contact me if you have any questions.

During the inspection, we talked about the benefits of a pollution prevention assessment. I encourage you to schedule a pollution prevention assessment for your business because there are often many opportunities for businesses like yours to reduce waste and save money. If you wish to talk about an assessment or if you have other questions about pollution prevention, please feel free to contact the Office of Compliance Assistance and Pollution Prevention (OCAPP) at (614) 644-3469. There is no charge for an assessment.
