**RE: SCOTT PROCESS SYSTEMS INC., STARK COUNTY, NOTICE OF VIOLATION (NOV)/
RETURN TO COMPLIANCE (RTC), OHR000175778, COMPLAINT NUMBER 7594**

Dear Mr. Alessandro:

On January 30, 2013 I as a representative of the Ohio EPA Division of Materials and Waste Management, conducted an inspection of Scott Process Systems Inc. (SPSI) located at 1160 Sunnyside Street, Hartville, Ohio, for compliance with Ohio's hazardous waste and used oil regulations. You, Thomas Bach and Brian Sedlock represented SPSI during that inspection.

The inspection was in response to a complaint received by Ohio EPA alleging leakage of oil and fuels and dumping of sand blast media into wetlands. I did not observe any mismanagement of used oil or fuels. I walked the banks of the stream/ditch on the west side of the property and along the west side of the parking lot on the north side of Sunnyside Street and I did not observe any evidence of dumping of blast media.

SPSI is a fabricator of process piping systems primarily for the power generation industry and chemical process industry. Fabrication is done in an indoor shop. Fabrication is by welding piping components together. Welding preparation can include cutting piping to length, beveling the ends and grinding. No solvent or chemical cleaning processes are used. No painting is conducted.

This letter identifies violations observed during the inspection and steps that must be taken to address those violations. Based on the facility documents reviewed and observations made during the facility walk-through, Ohio EPA has determined that SPSI has violated the following state used oil and universal waste regulations.

- 1. OAC 3745-273-13(D)(1) Small quantity handler must contain lamps in proper containers or packaging and containers or packaging must be closed.**

The facility generates used fluorescent lamps which it manages as universal waste and is classified as a small quantity handler of universal waste.

Approximately ten used 8 foot fluorescent lamps located in a maintenance trailer were observed leaning on a tool storage box and therefore were not in a container. These lamps were moved into a properly labeled and closed container during the inspection.

One container partially full of used 4 foot fluorescent lamps was not closed. That container was closed during the inspection.

These practices were not in compliance with the above cited regulation.

Placing the 8 foot lamps into a properly labeled and closed container and closing the container for the 4 foot lamps during the inspection abated this violation. No further action regarding this violation is necessary at this time. In the future all used lamps should be stored in properly labeled and closed containers.

2. OAC 3745-279-22(C)(1) Used oil containers and tanks must be labeled with the words "Used Oil"

SPSI collects used oil. I observed a tote of about 300 gallon capacity, partially full of used oil, outdoors to the west of Building No. 1. It was not labeled with the words "Used Oil". The tote was labeled during the inspection with the words "Used Oil".

Labeling the container during the inspection abated this violation. No further action regarding this violation is necessary at this time. In the future all containers and tanks holding used oil should be marked or labeled with the words "Used Oil".
