Dear Mr. Goehring:

On March 13, 2006, the Director of Ohio EPA issued NPDES Permit Number 0PR00140*BD to you authorizing the discharge from the treatment works. The permit, which expires on March 31, 2011, required you to submit a renewal application by October 2, 2010 in order to receive authorization to discharge beyond the expiration date.

As of the date of this letter, we have not received your renewal application. Failure to submit the application is a violation of the permit and subjects you to significant monetary penalties, if you intend to discharge after March 31, 2011.

To avoid formal enforcement action, you must submit the attached forms along with the \$200 application fee within 30 days of the date of this letter. Please contact me at (740) 380-5206 with any questions.
