Subject: Failure to Monitor Drinking Water

In order to return to compliance, Kopperts Korner School PWS must take the following actions:

1. Perform regular quarterly VOC monitoring according to your most recent monitoring schedule.
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.
