Subject: Failure to Monitor Drinking Water

Trotwood City PWS is in violation of Ohio Administrative Code Rule (OAC) 3745-81-24 for failing to monitor your drinking water during the Fourth Quarter of 2012 monitoring period and/or report results for the following contaminants: TOTAL TRIHALOMETHANES (TTHM), HALOACETIC ACIDS, FIVE (HAA5).

In order to return to compliance, Trotwood City PWS must take the following actions:

1. Notify your customers using the enclosed instructions and public notice.
2. Complete and send a verification form with a copy of the public notice to the mailing address below.
3. Perform quarterly monitoring during your scheduled week of each calendar quarter according to your most recent monitoring schedule.
4. Submit the sample for analysis to a certified laboratory on the enclosed list.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to enforcement actions. If you have any questions, or if the required sample analysis was performed, please call me at (614) 644-2752.
