Dear Mr. Eberhart:

On January 31, 2013 I inspected Eberhart's Service Center's facility on 272 Old Steubenville Pike Road in Cadiz, Ohio to determine Eberhart's Service Center's compliance with Ohio's hazardous waste and used oil laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). The inspection included a review of company operations and written documentation.

I found the following violation of Ohio's used oil laws:

- (1) **OAC Rule 3745-279-22(C), Used Oil Storage Requirements for Generators**
Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

At the time of the inspection, used oil was being stored in a tote that was not labeled with the words "used oil." During the inspection you labeled the tote with the words "used oil" returning Eberhart's Service Center to compliance with this rule.

General Comments

- (A) During the inspection you stated that you had a 4,000 gallon tank that you would like to install for used oil storage. You asked for information about the Spill Prevention Control and Countermeasure Requirements. These are U.S. EPA rather than Ohio EPA regulations. I have enclosed U.S. EPA's *Spill Prevention, Control, and Countermeasure Regulation: A Facility Owner/Operator's Guide to Oil Pollution Prevention* with this letter. This publication provides a general overview of the regulations. You may want to contact U.S. EPA directly using the contact numbers found on the last page of the guidance to ask your specific questions about secondary containment requirements.

- (B) In your used oil burning space heater you currently only burn used oil generated at your business. During the inspection you stated that in the past you had collected some used oil from Oxford Mining to supplement your used oil fuel supply. If you wish to do this again you must comply with certain requirements found in the used oil regulations. Enclosed with this letter is Ohio EPA's *Burning Used Oil in a Space Heater – For Businesses* guidance document. This guidance explains how Ohio's used oil rules apply to collecting used from another business to burn in your space heater. If you decide to pursue collecting used oil from another business, I recommend that you first contact Ohio EPA to discuss the particulars of your situation and what you will need to do to comply with the regulations.
