Dear Mr. Numbers:

Thank you for accompanying me during the Ohio Environmental Protection Agency's (Ohio EPA) November 8, 2012, compliance evaluation inspection of your facility. I inspected Shawnee High School (SHS), located at the address stated above, to determine the facility's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). This inspection consisted of a walkthrough of the facility and paperwork review. Pollution prevention options were also discussed during this inspection.

SHS is a part of large school system in Lima, Ohio. It operates a garage which houses its maintenance department operations. SHS has a large fleet of buses which are serviced in-house. SHS generates small amount of hazardous waste from maintenance painting throughout the school buildings. It also, once a year may collect unused paint cans and dispose of them. SHS also generates used oil which is stored in an above ground tank within the garage. During the inspection, you stated that you are currently giving the used oil to another business to burn in a used oil furnace. Finally, SHS is a small quantity handler of universal waste and manages its spent fluorescent light bulbs by recycling them off-site. Currently, SHS is operating as a conditionally exempt small quantity generator of hazardous waste.

Based on my observations, I found the following violation of Ohio's hazardous waste laws. SHS needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, SHS is requested to provide documentation to this office including the steps taken to abate this violation.

**1. OAC Rule 3745-279-24: Used Oil Transportation**

Generators must ensure that their used oil is transported only by transporters who have obtained a U.S. EPA identification numbers.

SHS failed to have its used oil removed by a transported that had obtained a U.S. EPA identification number.

In addition, you cannot burn used oil from other businesses in your space heater or give it to burn to other businesses, unless you or the other business has information that shows that the used oil meets the specification levels found in Ohio Administrative Code (OAC) rule 3745-279-11. Usually the demonstration that the used oil meets the specification levels in OAC rule 3745-279-11 is made by analysis of a representative sample of the used oil for the constituents listed in the rule. The demonstration can also be made by obtaining copies of analyses or other information documenting that the used oil fuel meets the specification. The person who first makes the claim that the used oil meets the specification (either you or the other business owner) is considered to be a used oil fuel marketer under the used oil rules. Until someone makes the demonstration that the used oil meets the specification it is subject to the used oil regulations including: prohibitions from burning used oil in space heaters not owned by the generator of the used oil; transportation requirements; storage, transportation and notification requirements.

**To abate this violation**, SHS must identify a used oil transported with the proper identification and inform me in writing of the name and U.S. EPA Identification number of this company. Keep in mind that you are allowed to self-transport in a company vehicle up to 55-gal. of used oil to a permitted used oil recycler or handler. SHS must provide documentation of how you are planning to manage your used oil from now on (either by explaining the demonstration of who will make an on-spec determination or by explaining what recycler you will now use.)

Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted electronically to [ed.pulido@epa.state.oh.us](mailto:ed.pulido@epa.state.oh.us). Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734. of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, SHS is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
