Thank you for submitting the requested information received by Ohio EPA via email on October 2, 2012. It should be noted that you mentioned that you have previously sent the letter dated June 23, 2012, but it was never received at the district office via regular mail. On October 2, 2012, you resent a copy of the letter to me via email. You submitted this information in response to my May 18, 2012, Notice of Violation. You emailed me documentation and an explanation of all the violations cited during my inspection including documentation on the proper waste evaluation of your spent paint booth filters, and evidence that several violations of the universal waste rules have been corrected.


My review of this documentation reveals that Cedar Point has abated the violation discovered during the May 2, 2012, compliance evaluation inspection as listed below:
