Dear Mr. Heigel:

I would like to thank you and your staff for the air permit applications that were submitted. Permits have been issued to cover the operations at TimberTech's Wilmington, Ohio facility. The two permits to install and operate (PTIO's), P0112971 and P0112996, will expire on February 21, 2023.

At present, the wood floor dryers 1-4, emissions units P026-P029, are listed in PTIO P0112996 as exempt and/or "de minimis"; however, please continue your review to assure that these emissions units are in fact either exempt under Ohio Administrative Code (OAC) 3745-31-03 and/or "de minimis" under OAC Rule 3745-15-05. Please contact this office by June 7, 2013, to confirm your determination about air pollution permit requirements for these emissions units.

Based on the issuance of PTIO's P0112971 and P0112996, and taking into account your continuing research into the emissions of units P026-P029 and possible permit requirements, it appears that TimberTech's Wilmington, Ohio, facility is in compliance with OAC Rule 3745-31-02 that requires all non-exempt and/or non "de minimis" air pollution sources (emissions units) be covered under air pollution permits.
