Subject: Notice of Violation for Failure to Respond to a Significant Deficiency

This letter is notification that the Village of Rayland has not complied with requirements issued during this Agency's last survey performed on November 21, 2006, in violation of rule 3745-81-60 of the Ohio Administrative Code. The village was notified in correspondence dated November 29, 2006, to respond in writing no later than 45 days, with time frames for:

- OAC 3745-95-03 Surveys and investigations states: "(A) The supplier of water shall conduct or cause to be conducted periodic surveys and investigations, of frequency acceptable to the director, of water use practices within a consumer's premises to determine whether there are actual or potential cross-connections to the consumer's water system through which contaminants or pollutants could backflow into the public water system. (B) The supplier of water, or his authorized representative, shall have the right to enter premises served by the public water system at all reasonable times for the purpose of making surveys and investigations of water use practices within the premises. (C) On request by the supplier of water, or his authorized representative, the consumer shall furnish the supplier, or his authorized representative, information on water use practices within the consumer's premises. (D) Paragraph (A) of this rule does not relieve the consumer of the responsibility for conducting, or causing to be conducted, periodic surveys of water use practices on his premises to determine whether there are actual or potential cross-connections in the consumer's water system through which contaminants or pollutants could backflow into a public water system or a potable consumer's water system." The public water system is not aware that they have right-of-entry for inspection. Installed backflow devices must be inspected annually, and the system should periodically resurvey all customers to ensure that cross-connections have been identified.

The water system must respond in writing within 15 days from the date of this letter with the required information. Failure to comply may result in further enforcement action.
