Dear Mr. Allen:

On September 2, 2009, Ohio Environmental Protection Agency (Ohio EPA), Division of Air Pollution Control (DAPC), Central District Office (CDO) conducted a full compliance evaluation (FCE) of the Quality Carriers facility located at 1200 South Houk Road in Delaware, Ohio. The purpose of the FCE was to document the facility's compliance status with the effective permits to install (PTIs).

On September 16, 2009, CDO issued a Notice of Violation (NOV) to Quality Carriers based upon the findings of the FCE. This NOV identified several specific findings and associated violations, and requested responses and additional information, in writing, from Quality Carriers to resolve the identified violations within 30 days of receipt of the NOV. To date, CDO has not received any response to the violations contained in the September 16, 2009 NOV.

According to a letter received by CDO from The WCM Group, Inc. on October 27, 2009, the facility is now operated by Qualawash Holdings LLC. CDO requests that Qualawash Holdings LLC respond to the September 16, 2009 NOV with the requested information no later than December 30, 2009. A copy of the September 16, 2009 NOV and copies of the applicable permits are enclosed. Be aware, the violations cited in the September 16, 2009 NOV are considered ongoing until such time as Qualawash Holdings LLC demonstrates compliance with the applicable permits and regulatory requirements.


