## NOTICE OF VIOLATION – ACTION REQUIRED

**Subject: Failure to Sample Drinking Water for Total Coliforms as Required**

MWCD Piedmont Camp P2 PWS is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring.

**Monitoring Period:** Fourth Quarter of 2008  
**Required Coliform Monitoring:** 1/Quarter  
**Sample Results Submitted:** None

To ensure the safety of drinking water provided by your system monitoring for total coliforms is essential.

**ACTION REQUIRED:**

- 1. Notify the people served by this water system** using one or more of the methods and the timing as required by OAC, Rule 3745-81-32 to reach all persons served. The appropriate methods for your system are listed below.

**Timing:**

As soon as practical, but no later than 30 days after learning of the violation:

**Methods:**

- Posting in conspicuous location, such as bulletin boards, restrooms, drinking fountains, vending areas

Posted notices must remain in place as long as the violation or situation exists, but in no case less than seven days (even if the violation is resolved). The language in italics on the enclosed public notice is mandatory and must be included, as written. Do not make changes to the public notice without consulting with the Ohio EPA beforehand.

- 2. Complete the enclosed Verification Form within 10 days of issuing the Public Notice** and mail it to Ohio EPA - Southeast District Office. Include a copy of each notice distributed, published or posted.

# DRINKING WATER NOTICE

## Monitoring requirements were not met for MWCD Piedmont Camp P2 PWS

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During Fourth Quarter of 2008, we did not monitor or test for total coliform bacteria, and therefore cannot be sure of the quality of your drinking water during that time.

### What Should I Do?

- *There is nothing you need to do at this time. You do not need to boil your water or take other corrective action.*
- *This notice is to inform you that Mwcd Piedmont Camp P2 PWS did not monitor and report results for the presence of total coliform bacteria in the public drinking water system during the Fourth Quarter of 2008 time period, as required by the Ohio Environmental Protection Agency.*

### What is being done?

Upon being notified of this violation, the water supply was required to have the drinking water analyzed for the above mentioned parameters. The water supplier will take steps to ensure that adequate monitoring will be performed in the future.
