

Dear Mr. Huth:

On February 14, 2013, Sherry Slone and I of the Ohio EPA Division of Materials and Waste Management conducted a hazardous waste compliance evaluation inspection at Gougler Industries (Gougler), located at 705 Lake St., Kent, Ohio. We inspected Gougler to determine its compliance with Ohio's hazardous waste laws, used oil laws and universal waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). You and Bob Holloway represented Gougler during the inspection.

Gougler does light assembly of construction equipment at this facility. Several parts washers are used to clean parts prior to assembly. The solvent used in the parts washers appears to be a high flash solvent, thus making the spent solvent a non-hazardous waste stream. Used oil is shipped off site to a used oil recycler. The only hazardous waste stream we identified is the paint waste generated from painting operations. Waste paint is generated at a rate of about 3 gallons a month making Gougler a conditionally exempt small quantity generator of hazardous waste.

Copies of the checklists completed for this inspection are enclosed. The following violation was noted:

- OAC 3745-279-22(C)(1); Containers and above ground tanks that are used to store used oil must be labeled with the words, "Used Oil".**


In the building where the wash bay is located, we noted a 250 gallon tote being used to collect used oil and lathe coolant. The tote was not labeled with the words used oil as is required by the rule. The tote was labeled with the words "Used Oil", by placing a label on it, thus abating the violation. **No further action is required regarding this violation.**

At the time of the inspection Gougler was not accumulating any spent fluorescent bulbs. Fluorescent and some other types of lamps contain mercury and may contain other hazardous metals. The best method of managing spent fluorescent lamps is to save them in a properly labeled and closed container and have them picked up by a lamp recycler. I gave you two fact sheets on the management of fluorescent bulbs and a list of recyclers to contact in the future.
