

Dear Mr. Witzigreuter:

Thank you for cooperating with our April 17, 2013 hazardous waste inspection at Gateway Tank, Inc. located at 828 Miller Rd. in Avon. Robert Almquist and I represented the Ohio EPA and you represented Gateway Tank. We inspected your site to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and with hazardous waste, universal waste, and used oil rules as found in Chapter 3745 of the Ohio Administrative Code (OAC).

Gateway Tank assembles large tanks at their customer's site. The only hazardous waste generated at this site is a reducer that is used to clean equipment after painting. This equipment is used only 2 or 3 times per year and only about 20 gallons of waste is generated per year. The waste reducer is put into one of the steel drums stored outside at the back of the property. Additionally used oil is generated from form releasing activities. The used oil is stored in totes also outside at the back of the property. No spent lamps were accumulating and none were being generated at the time.

The following violations were noted.

1. Waste Determination – OAC 3745-52-11

At the back of the property were 8 steel drums and 1 plastic drum containing various amounts of unknown liquids. Many had been left open so probably contained some rain water. It was unknown which contained the spent reducer or what other wastes might be in them.

As a generator of waste you are required to determine if those wastes are hazardous wastes. Please immediately identify the contents of these drums and submit your determination to us. You indicated you might go ahead and have these drums properly disposed off-site. If so, also submit manifests or shipping papers that indicate where these wastes were shipped.

We suggested that you set up a drum for newly generated hazardous waste in a more protected location near its point of generation and clearly marked with its contents. Please refer to the documents given to you during the inspection for additional information.

2. Used Oil Labeling – OAC 3745-279-22(C)

At the back of the property also were about 8 totes of used oil. None of the totes were labeled with the words "used oil" as required. Please immediately label all of the totes containing used oil with the words "used oil" and submit pictures confirming this. If you have already sent these off-site for proper recycling please submit the shipping papers that indicate where the oil was shipped. Also confirm that in the future containers for used oil will be labeled "used oil".

3. Release of Used Oil – OAC 3745-279-22(D)

There was some spillage/staining on the ground by one of the totes of used oil. Please immediately clean up and properly manage the used oil and dirt that is scraped up as required. Submit pictures to demonstrate that the soil is no longer stained in this area.

Gateway Tank needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, you are requested to provide documentation to this office including the steps taken to abate the violations cited above. Please be advised that the violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, Gateway Tank is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
