Notice of Violation

Dear Resident:

You are hereby notified that the Ohio Environmental Protection Agency (Ohio EPA) finds you to be in violation of Ohio open burning regulations. On April 17, 2013, it was determined that past open burning of waste materials occurred at your residence at 6931 Highland Trail West in Hillsboro, Ohio.

The violations committed include, but are not limited to the following:

- Open burning of garbage and/or residential waste for disposal purposes.

Open burning of garbage and/or residential waste for disposal purposes is a violation of Ohio Administrative Code (OAC) rule 3745-19-04; *Open burning in unrestricted areas*, and Ohio Revised Code (ORC) Section 3704.03.

You must cease all illegal open burning.

Any subsequent violations will be referred to our Central Office for enforcement action with the recommendation for a significant monetary penalty. Ohio EPA reserves the right, pursuant to Chapters 3704, 3714, 3734, 3745 and 3750 of the Ohio Revised Code and any other applicable state or federal laws or regulations, to seek civil and/or criminal action, reimbursement of response costs and any other appropriate legal or equitable relief for any violation of law.






