## NOTICE OF VIOLATION – ACTION REQUIRED

**Subject: Failure to Conduct Required Repeat Total Coliform and Ground Water Rule Monitoring**

Orient Sunoco PWS is in violation of monitoring requirements for Total Coliform established by Ohio Administrative Code (OAC), Rules 3745-81-21 and 3745-81-42 for First Quarter of 2013.

Ohio EPA records indicate that a total coliform-positive sample was collected from this water system on 2/19/2013 and the required repeat samples were not collected. For your water system the four repeat samples also satisfy the Ground Water Rule requirement for the initial raw water sample. To ensure the safety of drinking water provided by your system monitoring with all of the required repeat samples is essential.

### **IMMEDIATE ACTION REQUIRED:**

- 1. Per our settlement meeting on February 26, 2013, your facility was required to remain on a boil alert until repeat monitoring was performed for unsafe bacteriological samples collected in October 2012. To date the repeat monitoring has not been conducted and the boil alert should have remained in affect. You need to extend the boil alert by posting in accordance with OAC, Rule 3745-81-32 using one or more of the following methods to reach all persons served.**
  - Hand delivery to persons served by the water system;
  - Posting in conspicuous locations, such as bulletin boards, restrooms, drinking fountains, vending areas;
  - Send to parents or guardians of children at schools or day care facilities;
  - Another delivery method approved in writing by the director;
  - Posted notices must remain in place for as long as the violation exists, but in no case for less than seven (7) days (even if the violation is resolved). The language in italics on the enclosed public notice is mandatory and must be included, as written. Do not make changes to the public notice without consulting with Ohio EPA beforehand.
- 2. Complete the enclosed verification form, within 10 days of issuing the Public Notice and mail it to Ohio EPA - CDO. Include a copy of each notice distributed, published or posted.**

3. The boil alert must remain in affect until two sets of total coliform-negative samples are obtained to discontinue the Water Use Advisory. Each required set is comprised of four (4) repeat samples. One set of repeats samples must reference the total coliform positive sample #121147301 collected on 10/31/2012 and the other set of repeats must reference the total coliform positive sample # 130161204 collected on February 19, 2013.



## PUBLIC NOTICE - DRINKING WATER WARNING

Tests show coliform bacteria in water

BOIL YOUR WATER BEFORE USING  
OR USE BOTTLED WATER

Sampling conducted for our water system showed total coliform bacteria were found. We were required to collect four repeat samples within 24 hours of notification of any total coliform positive result to determine if *E. coli* or fecal coliform bacteria were present in our distribution system and source. These bacteria can make you sick, and are a particular concern for people with weakened immune systems. We did not collect all the required repeat samples, and therefore cannot be sure that the water does not pose an acute risk to human health.

### What should I do?

- *DO NOT DRINK THE WATER WITHOUT BOILING IT FIRST. Bring all water to a boil, let it boil for at least one minute, and let it cool before using, or use bottled water. Boiled or bottled water should be used for drinking, making ice, brushing teeth, washing dishes, and food preparation until further notice. Boiling kills bacteria and other organisms in the water.*
- *Fecal coliforms and E. coli are bacteria whose presence indicates that the water may be contaminated with human or animal wastes. Microbes in these wastes can cause short term effects, diarrhea, cramps, nausea, headaches, or other symptoms. They may pose a special health risk for infants, young children, some of the elderly, and people with severely compromised immune systems.*
- *The symptoms above are not caused only by organisms in drinking water. If you experience any of these symptoms and they persist, you may want to seek medical advice. People at increased risk should seek advice about drinking water from their health care providers.*

### What happened?

Bacterial contamination can occur when increased run-off enters the drinking water source (for example, following heavy rains). It also can happen due to a break in the distribution system (pipes) or a failure in the water treatment process.

### What is being done?
