**Re: [NOV-RTC] Heath Motor Sports CDO Complaint #4368,
2/25/2013, Franklin County (nonnotifier)**

Thanks to you and Jason Scott for your time during my visit to Heath Motor Sports at 70 Central Parkway on February 25, 2013. The purpose of my visit was to investigate a complaint Ohio EPA had received concerning the management and disposal of used oil and used oil filters from your business. Ohio's laws under Chapter 3745 of the Ohio Administrative Code and Chapter 3734 of the Ohio Revised Code establish a system for safe and responsible management of used oil and hazardous wastes. Your business appeared to be a conditionally exempt small quantity generator. This letter summarizes our findings.

One violation was noted, but has now been abated/resolved:

Used Oil Container Marking, OAC Rule 3745-279-22(C)(1): Containers for accumulating/ storing used oil must be clearly marked as "Used Oil".

Two used oil caddy containers in the shop, and a tank outside (under cover) lacked the proper marking as "used oil".

This problem was corrected by your personnel during my visit.

In addition, I offer these comments/suggestions:

- Used oil filters should be punctured at the dome end and drained at least 24 hours, as a best management practice, before being recycled as scrap metal. Some guidance on that is enclosed.
- Ohio EPA is assigning an "internal" tracking I.D. number to your facility.
- I am enclosing a checklist completed during this inspection.
