Dear Mr. Edwards:

On May 21, 2013, I inspected the Jefferson County Vocational School in Bloomington, Ohio to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). During the inspection I also helped you identify ways to prevent pollution by reducing waste. This letter will explain the violation I found and what you need to do to correct the violation.

I found the following violation of Ohio's hazardous waste laws:

1. **Used oil storage requirements for generators, OAC rule 3745-279-22(C)(1):**
Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

During the inspection, the used oil containers were not labeled as required above. Facility personnel labeled the containers during the inspection therefore, no further action is required.

General Comment

During the inspection disposal documentation could not be presented regarding the disposal of hazardous paint wastes and recent used oil shipments. This information is necessary to document compliance with Ohio Revised Code 3734.02(F) which states that a generator of hazardous wastes must ensure delivery of hazardous waste(s) to an off-site permitted Treatment, Storage, or Disposal facility. Likewise, used oil is required to be hauled only by transporters that have obtained a U.S. EPA ID number. Jefferson County Vocational School needs to immediately take the necessary measures to demonstrate compliance with Ohio's environmental laws. **Within 14 days** of receipt of this letter, Jefferson County Vocational School is requested to provide documentation (manifests/shipping papers) to this office including the steps taken to demonstrate

compliance. Documentation of steps taken to demonstrate compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to melody.stewart@epa.ohio.gov.

Please be aware that violations may be cited upon review of the requested documentation. If violations are cited, failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you demonstrate compliance.
