**RE: Notice of Violation**

Dear Mr. Sibrel:

You are hereby notified that the Ohio Environmental Protection Agency (Ohio EPA) finds you to be in violation of Ohio open burning regulations. On April 26, 2013, you were opening burning land clearing waste at Mr. Robert S. Johnson's property, parcel 09-13-000-089.00, along State Route 134, Dodson Township in Highland County, Ohio.

The violations that have been committed include, but are not limited to:

- Open burning of land clearing waste within a thousand feet of inhabited buildings, not located on said premises and without applying for and obtaining, a written open burning permit from Ohio EPA.

The activities identified above are in violation of rule 3745-19-04 of the Ohio Administrative Code; *Open burning in unrestricted areas*, section 3704.03 of the Ohio Revised Code (ORC).

**You must cease all illegal open burning.**

Any subsequent violations will be referred to our Central Office for enforcement action with the recommendation for a significant monetary penalty. Ohio EPA reserves the right, pursuant to chapters 3704, 3714, 3734, 3745, and 3750 of the Ohio Revised Code and any other applicable state or federal laws or regulations, to seek civil and/or

criminal action, reimbursement of response costs and any other appropriate legal or equitable relief for any violation of law.




