Dear Sirs:

In a letter dated May 2, 2013, Ohio EPA provided notice of violations occurring at 1214 Poland Avenue, Youngstown, in Mahoning County, Ohio. The violations were originally communicated to you during a meeting conducted on January 23, 2013. On May 21, 2013, Ohio EPA received a written response as to the status of the scrap tire removal and attached to the letter were shipping papers documenting scrap tires being transported via Echo Scrap Tire Transporter. On May 29, 2013, Ohio EPA performed a follow-up inspection of property to determine compliance with Ohio's solid waste laws and regulations. Mr. Meenachan was present during the inspection. As a result of the inspection, Ohio EPA determined that the owner/operator abated the following violations:



OAC Rule 3745-27-56(A)	Scrap Tire Registration	Scrap tires were removed. Thomas Peters will no longer be transporting scrap tires without being a registered scrap tire transporter with the State of Ohio.
