Dear Mr. Glass:

On April 28, 2013, Ohio EPA received a complaint regarding the mismanagement of fluids at your facility. The complainant alleged that approximately 30 to 40 barrels were being rinsed out and the fluids were going into a floor drain. On May 1, 2013, I met with Brett Jursik and I inspected Heavy Duty Industrial Services' Wintersville, Ohio facility to determine Heavy Duty Industrial Services' compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). During the inspection I did not observe barrels and Mr. Jursik stated that barrels were not brought back to the facility. It appears that the allegations from the complainant were unfounded. This letter will explain the violation I found and what you need to do to correct the violation.

I observed the following violation of Ohio's hazardous waste laws:

1. **Used oil storage requirements for generators, OAC rule 3745-279-22(C)(1):**  
Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

During the inspection, the used oil containers were not labeled as required above. Facility personnel labeled the containers during the inspection therefore, no further action is required.
