Dear Mr. Myers:

On April 4, 2013, you accompanied Gary Deutschman and me during the Ohio Environmental Protection Agency's (Ohio EPA's) hazardous waste compliance evaluation inspection of your facility, Spangler Candy Company (hereafter referenced as SCC) located at 400 North Portland Street in Bryan, Ohio. Specifically, we inspected your facility to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and Chapter 3745 of the Ohio Administrative Code. Pollution prevention options were also discussed during this inspection. This letter will explain the violations found and what you need to do to correct these violations.

SCC manufactures candy. Specifically, candy canes, dum-dum suckers, Saf-T-pops and marshmallow peanuts. Wastes generated include universal waste lamps and batteries, paint/solvent waste, COD vials, antifreeze, obsolete colorings/flavorings, and used oil.

At the time of our inspection, SCC was operating as either a small quantity generator of hazardous waste or a conditionally exempt generator. Typically, a checklist is sent so that you can see what your company was evaluated for during the inspection. I have not provided a copy with this letter as there is additional information I need to determine SCC's generator status before I can complete the checklist. Once I receive the requested information, I will include a checklist in my next correspondence.

At this time, I found the following violations of Ohio's hazardous waste laws:

1. Waste Evaluation, OAC Rule 3745-52-11:

Any person who generates a waste must determine if that waste is a hazardous waste by using generator knowledge or by testing the waste.

At the time of the inspection, SCC did not have waste evaluation documentation for the obsolete flavorings and colorings. SCC has historically disposed of these materials as non-hazardous waste at Adrian Landfill in Michigan.

On April 10, 2013, SCC submitted to me all of the material safety data sheets (MSDS) which coordinate with the current waste flavorings and colorings. Ten of the MSDS show a flashpoint of less than 140 degrees Fahrenheit.

The ten which have been identified are:

For this reason, these ten wastes above are hazardous for ignitability (D001). Because this determination has been made, this violation is considered abated.

2. Universal Waste Management, OAC Rule 3745-273-13(D)(1):

Universal waste lamps must be in closed containers which are adequate to prevent breakage.

SCC had several lamps not in a container or box and/or sitting in open boxes and containers.

To abate this violation, SCC must submit to me a photo of the area showing all spent lamps in closed boxes or containers.

3. Universal Waste Labeling, OAC Rule 3745-273-14(E):

All lamps, containers or packages must be labeled with the words "universal waste lamps", "waste lamps" or "used lamps".

SCC did not have lamps in boxes or containers that were labeled properly.

To abate this violation, SCC must submit to me a photo showing the boxes and containers properly labeled with the words "universal waste lamps", "waste lamps" or "used lamps". This can be done via email as well.

I gave you a copy of the fact sheet, Fluorescent Lamps: What You Should Know, with information on how to properly manage lamps in the future.

Request For Information

In addition to the above, SCC must provide the following additional information:

- ⇒ SCC must provide me with a copy of the last manifest which accompanied your paint/solvent waste off-site for disposal.
- ⇒ SCC must submit copies of 2011 waste manifests for obsolete food colorings and flavorings.
- ⇒ If SCC has inventory of what specific colorings/flavors were shipped off in past shipments to Adrian Landfill, you must submit this information.
- ⇒ Additionally, what is the protocol for moving the colorings and flavorings out of the product area to the waste area? How often are expiration dates assessed? Daily, Weekly or Monthly? When they are determined obsolete, are they moved immediately? Are records kept of when (specific date) each container is moved?
- ⇒ How are the weights (in lbs.) of the colorings and flavors determined? Are the containers weighed?
- ⇒ SCC was going to ask maintenance folks what was contained in the two drums located outside by the scrap metal. SCC must tell me what is contained in these drums.

SCC needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, SCC is requested to provide documentation to this office including the steps taken to abate the violations cited above. Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to wendy.miller@epa.ohio.gov. If circumstances delay the abatement of violations, SCC is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.

In regards to pollution prevention, there may be other options or uses for food colorings/flavorings which are expired. I suggest contacting our Office of Compliance Assistance and Pollution Prevention at **(800) 329-7518**.
