NOTICE OF VIOLATION

Dear Mr. Wilson:

This confirms our conversation of June 3, 2013 wherein I advised you that you were open burning in violation of Ohio Administrative Code 3745-19-03(A). These actions are subject to fines and penalties.

Specifically, at 1069 Murnan Road, Galloway, Ohio, and on May 31, 2013, you were open burning agricultural waste within 1,000 feet from the nearest inhabited building off your premises. Also, you failed to provide Notification for burning within a restricted area. Also, you were burning plastic and fiberglass materials.

This letter is not a final action of the Director of the Ohio EPA and is intended only as a notification of a violation of the Ohio environmental laws and regulations. It does not preclude Ohio EPA or any other governmental entity from further enforcement action.
