NOTICE OF VIOLATION**

Dear Mr. Pickering:

This office has received the non-compliance notification for the above referenced facility. Our review indicates violations of the conditions of your NPDES permit. The specific instances of non-compliance and/or deficiencies were as follows:

On June 7, 2013, approximately 900 gallons of hydrostatic test water was discharged to the ground. The discharge was not sampled according to the facility's general permit for hydrostatic test water. In addition, this type of discharge is not permissible under the general industrial storm water permit. There is no individual NPDES for the facility. The failure to properly sample the discharge under the hydrostatic test permit is a violation of the hydrostatic testing permit. Since this is not a permissible discharge under the facility's general industrial storm water permit, this is an unauthorized bypass, and a violation of this permit.

Westway Terminal Cincinnati, LLC must provide documentation of the employee training regarding this matter. In addition, procedures must be developed and put into place to prevent this from recurring. Copies of these documents must be provided to this office within one week of being completed.

Please be advised that failure to satisfy monitoring or reporting requirements of your NPDES permit may be cause for enforcement action pursuant to the Ohio Revised Code Chapter 6111.
