Dear Mr. Novak:

On June 20, 2013, I inspected Advanced Repair Co. located at 4125 Bradley Road, Cleveland, Ohio. The purpose of this was to determine if this facility was in compliance with Ohio's hazardous waste, universal waste and used oil laws and rules as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC).

Based on the inspection, you do not normally generate hazardous waste. You do generate used motor oil and used cooking oil. The used motor oil is regulated as a used oil but the used cooking oil is not. The following documents are enclosed:

The following violations were found: (See also the enclosed checklist.)

1. **OAC Rule 3745-279-22(C) - Used oil labels.**

This rule requires containers, aboveground tanks, and fill pipes for underground tanks used for used oil to be labeled or marked clearly with the words "Used Oil."

Advanced Repair violated this rule by having containers of used oil that were not labeled as used oil. You sent me a copy of a shipping paper for the shipment of 600 gallons of used oil on June 27, 2013 to Environmental Specialists in Youngstown, Ohio. Please confirm that this shipment included all the used oil containers that were there on June 20, 2013, and/or that all future containers of used oil will be labeled as used oil.

2. **OAC Rule 3745-279-22(D) - Response to releases of used oil.**

This rule requires that upon detection of a release of used oil to the environment, the generator must clean up and manage properly the released used oil and other materials.

Advanced Repair violated this rule by having what appeared to be used oil on the ground. A photograph of this is shown below. This contaminated soil/gravel must now be removed and disposed of properly. At a minimum, it must be shipped to a solid waste landfill. Please send me documentation showing that this has been done. Please also ensure that no used oil contamination remains where the used oil containers that have been recently shipped were.



You need to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, you are requested to provide the above specified documentation to me including the steps taken to abate the violations.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. If circumstances delay the abatement of violations, you are requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.

I saw a burn barrel during the inspection which is shown in the photograph below. This may be illegal open burning. I have enclosed the following document:
