**Notice of Violation**

Dear Ms. Dornbusch:

You are hereby notified that the Ohio Environmental Protection Agency (Ohio EPA) finds you to be in violation of Ohio open burning regulations. On July 10, 2013, you stated that a foster child was opening burning waste at your residence, parcel 24-05-000-002.01, 6110 Roundhead Road, New Vienna, Ohio 45159.

The violations that have been committed include, but are not limited to the following:

- Open burning is not used for waste disposal purposes.

The above identified activity is in violation of Ohio Administrative Code (OAC) rule 3745-19-04(B)(2)(b); *Open burning in unrestricted areas*, and Ohio Revised Code (ORC) Section 3704.03.

**You must cease all illegal open burning.**

Any subsequent violations will be referred to our Central Office for enforcement action with the recommendation for a significant monetary penalty. Ohio EPA reserves the right, pursuant to Chapters 3704, 3714, 3734, 3745, and 3750 of the Ohio Revised Code and any other applicable state or federal laws or regulations to seek civil and/or criminal action, reimbursement of response costs and any other appropriate legal or equitable relief for any violation of law.


