**RE: NOTICE of VIOLATION / Wastewater Management Permitting Requirements
Land Application Management Plan Application**

Dear Mr. Winner:

I am writing this letter to provide a summary of our conversation during our meeting on July 10, 2013. During our meeting at your meat farm located at 2259 State Route 502, you indicated that the ultimate fate of wastewaters generated from the site associated with the meat butchering facility at 8544 State Route 705, is land application. The land application of wastewaters without a permit is a violation of Ohio Administrative Code (OAC) 6111; hence, this is a Notice of Violation. The application of wastewaters to the land shall be conducted in a manner that is in accordance with the Ohio Revised Code (ORC) 3745-45-13, Land Application Systems.

In order to comply with provisions of the above, a Permit-to-Install (PTI) must to be obtained from Ohio EPA. During our meeting on the 10th, the forms to make application for land application of wastewaters were provided to you for your convenience. It is recommended that the services of a professional engineer or other professional services be acquired to assist you in completing the land application plan.

The approvable PTI package is to be submitted to the Southwest District Office of Ohio EPA within six months of the date of the receipt of this letter. A letter summarizing the progress of the approvable PTI, must be sent to same office at my attention and must be received within three months of the date of receipt of this letter.


