Dear Ms. Carmack:

On July 9, 2013, Wendy Miller and I conducted a compliance evaluation inspection at Professional Transportation, Inc. (PTI) located at 30801 Drouillard Road in Walbridge, Ohio. We inspected PTI to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). Pollution prevention options were also discussed during this inspection.

During our inspection, we spoke with Mr. Richard Glesser and Ms. Ellen Overmyer. PTI specializes in driving railroad train crews/personnel to their designated work locations. Mr. Glesser stated that the Drouillard Road location is where drivers switch from their personal vehicles to one of the PTI vans. All repairs and service work on the PTI fleet are done off-site. No used oil is generated and no painting is done on-site. PTI generates spent fluorescent bulbs, which are managed as universal waste. Mr. Glesser stated that PTI leases the building which is owned by the Village of Walbridge.

At the time of our inspection, PTI was operating as a non-generator of hazardous waste.

We found the following violations of Ohio's hazardous waste laws:

1. OAC Rule 3745-273-13(D)(1): Universal Waste: Fluorescent Lamp Management:

A small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, or damage that could cause leakage under reasonably foreseeable conditions.

PTI did not store the spent fluorescent lamps in containers that were closed. Specifically, PTI had one box of spent fluorescent lamps located in the supply room that was open.

At the time of our inspection, PTI closed the box of spent fluorescent lamps located in the supply room.

Therefore, this violation is considered abated.

3. OAC Rule 3745-273-14(E): Universal Waste: Fluorescent Lamp Labeling:

Each lamp or a container or package in which such lamps are contained must be labeled or marked clearly with one of the following phrases: "Universal Waste - Lamps", "Waste Lamps" or "Used Lamps".

PTI did not have one box of spent fluorescent lamps located in the supply room properly labeled.

At the time of our inspection, PTI properly labeled the box of spent fluorescent lamps located in the supply room.

Therefore, this violation is considered abated.

4. OAC Rule 3745-273-15(A): Accumulation Time for Universal Waste Batteries and Lamps:

A small quantity handler of universal waste may accumulate universal waste for no longer than one year from the date the universal waste is generated, or received from another handler.

PTI was not able to demonstrate the length of time the universal waste lamps were being accumulated on-site.

In order to correct this violation, PTI must immediately ship off-site for recycling the spent fluorescent lamps that have been in storage for greater than one year. PTI must submit a copy of the receipt for the shipment of spent fluorescent lamps sent off-site for recycling to demonstrate compliance.

5. OAC Rule 3745-273-15(C): Accumulation Time for Universal Waste Batteries and Lamps:

A small quantity handler of universal waste who accumulates universal waste shall be able to demonstrate the length of time the universal waste has been accumulated.

PTI was not able to demonstrate the length of time the universal waste lamps were being accumulated on-site.

In order to correct this violation, PTI shall establish a written procedure for how you plan to track the length of time the universal waste is accumulated on-site. PTI may want to contact the Village of Walbridge to arrange a tracking procedure with them as the owners of the building. PTI shall submit a copy of this procedure to Ohio EPA, NWDO.

6. OAC Rule 3745-273-16: Universal Waste Employee Training:

A small quantity handler of universal waste shall ensure that all employees are thoroughly familiar with proper waste handling and emergency procedures, relative to their responsibilities during normal facility operations and emergencies.

PTI has not ensured that all employees are thoroughly familiar with proper waste handling and emergency procedures.

In order to correct this violation, PTI must thoroughly familiarize (train) its universal waste fluorescent bulb handlers in proper handling and emergency procedures. Copies of two universal waste guidance documents were given to you at the time of our inspection and are also enclosed. Please review this information with your universal waste fluorescent bulb handlers and submit documentation (sign-in sheet) to demonstrate this review has been completed.

Enclosed you will find a copy of the checklists that were completed during our inspection.

PTI needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within **14 days** of receipt of this letter, PTI is requested to provide documentation to this office including the steps taken to abate the violations cited above.
