Dear Mr. Brown:

Thank you for meeting with Amber Hicks and me during the Ohio Environmental Protection Agency's (Ohio EPA's) April 23, 2013, compliance evaluation inspection of your Custom Repair shop (hereafter referred to as JBCR) located at 1080 Navajo Drive in Bluffton, Ohio. JBCR has been operating for about three years.

We conducted this hazardous waste compliance evaluation inspection to determine your facility's compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and Chapter 3745 of the Ohio Administrative Code (OAC). We toured your facility and discussed your business and potential for generating hazardous waste.

JBCR is a vehicle service shop. You do oil changes, tune-ups, brake and tire jobs, etc. No body work is done. Wastes generated in the shop include, used oil, used oil filters, antifreeze and battery cores. Lamps that are spent will be removed by the building owner and recycled. You have not had any to date. At the time of our inspection, you were operating as a non-generator of hazardous waste.

Based on my inspection, I found the following violation of Ohio's hazardous waste laws:

**1. Off-site shipments of used oil by generators.
OAC Rule 3745-279-24**

Generators shall ensure that their used oil is transported only by transporters who have obtained U.S. EPA identification numbers.

You stated that your used oil is put in with the neighboring business (same address), Bluffton Flying Service's tote, and is taken to a local business, Anderson Tractor. Anderson Tractor has not notified Ohio EPA that they are a used oil recycler, used oil collection center or marketer, thus they do not have a U.S. EPA identification number. You cannot take your used oil to Anderson Tractor.

Used oil generators have three options for handling their used oil: 1) Generators must have their used oil transported by an entity that has a U.S. EPA identification number and ensure their used oil is recycled;

2) Generators may transport less than 55-gallons of their own used oil to a registered used oil collection center; or 3) generators may burn their own used oil in an on-site space heater as long as all applicable requirements are met. Please consult the Used Oil fact sheets given to you during the inspection for more information.

- ***In order to abate this violation, you must either 1) submit information indicating what transporter with a U.S. EPA identification number will be picking up your used oil and the name of the facility that will actually recycle the used oil; or 2) a summary outlining how you plan to manage your used oil if you decide to purchase a used oil furnace.***

I have enclosed a list of used oil recyclers.

JBCR needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, JBCR is requested to provide documentation to this office including the steps taken to abate the violations cited above.

Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to wendy.miller@epa.ohio.gov.
